Social Media ("Contest")
Official Rules**

There is no purchase necessary to enter or win. However, some restrictions do apply to be eligible to enter or win, so that all entries have an equal chance of winning. Please see below for official rules and complete details.

Eligibility

To be eligible to enter to win the Contest, I require a few simple things. You must:

- be 18 years of age or older;
- have your primary residence in Alberta
- not be an employee, director, agent or contractor of ATB Financial (ATB) or its subsidiaries (which means a company controlled by ATB)

How You Can Enter

Contest Period

The Contest Period is from March 27, 2019 (7:01:00 am MST) to April 10, 2019 (4:00:00 pm MST).

Grand Prize(s)

There is one (1) grand prize in total.

ATB has generously offered to provide the prize for this Contest.

One (1) winner will win an ATB Prosper investment account with a balance of \$500 CAD (if the winner has an existing ATB Prosper investment account, ATB will deposit \$500 CAD into the ATB Prosper investment account; no other ATB account is eligible) .

Winner Selection

Odds of winning are dependent on the number of eligible entries received through the social media comments and message on my blog post.

One winner will be selected by a random draw (“Draw”) on or about April 4, 2019 at about 4:00:00 pm MST (“Selection Date”) in Edmonton, Alberta, from among all eligible entries received up to 4:00:00 pm MST on the Selection Date. The winner will be contacted by direct message or email, and will be required to correctly answer an unaided mathematical skill testing question. Be sure to check your email and social media messages, often. You will be given 48 hours to respond from the time I first contact you. If you don’t respond within 48 hours, you forfeit the prize.

After you respond, the winner will be provided clear instructions on how to claim your prize with ATB. You will be required to sign a Declaration and Release in order to claim your prize.
